Preliminary Draft Ripon City Plan

I am delighted to enclose for your consideration a copy of the preliminary draft Ripon City Plan. This is your opportunity to have a greater say in the way in which the city develops over the next 15 years.

It is being proposed by the Ripon City Plan Committee which comprises of representatives from a number of the city's organisations: the City Council, the Chamber of Trade, Greater Ripon Improvement Partnership, the Civic Society, and the Cathedral Chapter.

The Committee's preparation of this preliminary draft plan has been based upon your responses to the consultation we held last year asking "How could Ripon be better for you?"

The publication of this preliminary draft is a significant milestone and your comments and views are once again really important in helping us complete the final draft plan. We can then present this to you next year before it is submitted to an independent examiner. Once the examiner has reported that the plan can go forward, as a resident of the City, you will be asked by a referendum whether you support our proposals for the Ripon City Plan.
